**DUTIES OF THE POSITION** The candidate must possess the ability to teach Literacy courses in the Multiple Subject (elementary) and Single Subject (secondary) credential programs and in Masters Programs. In addition, the candidate may teach other classes in the credentials and/or Masters Programs depending on areas of expertise. Assume roles and responsibilities as a member of the Department of Teacher Education. In addition to teaching, all faculty must be able to supervise candidates in fieldwork. Please note that teaching assignments at California State University, East Bay include courses at the Hayward, Concord and Online campuses and will likely include evening and weekend classes. Along with teaching, all faculty have advising responsibilities, assist the department with administrative and/or committee work, and are expected to assume campus-wide committee responsibilities.

- Demonstrated successful university teaching experience

- Reading Specialist Credential
- Knowledge of methods to teach emergent/bilingual/multilingual learners
- Knowledge and teaching expertise in one or more of the following: literacy assessment, dyslexia, reading intervention, biliteracy, curriculum design, technology/online instruction, adult learning.
- Additionally, experience with one or more of the following may be helpful: socio-emotional learning, Restorative Justice, assessment, and/or ethnic studies/social studies.
